Introduction

- The date of establishment of the New South Wales Civil and Administrative Tribunal, NCAT, is 1 January 2014, by operation of s 7 of the Civil and Administrative Tribunal Act 2013. On the same day, the Administrative Decisions Tribunal of New South Wales, the ADT, is abolished under cl 3 of Schedule 1 to that Act.
- Many of the proceedings that would formerly have been heard in the ADT are now to be heard in the Administrative and Equal Opportunity Division of NCAT. Furthermore, under Schedule 1 to the *Civil and Administrative Tribunal Act,* proceedings that were commenced in the ADT prior to 1 January 2014 will be heard and determined by NCAT after that date.
- 3. Prior to 1 January 2014, there were a number of guidelines and a practice note relating to practice and procedure published by the ADT.
- 4. In order to achieve as non-disruptive a transition of proceedings from the ADT to NCAT as possible, it is useful to continue the operation of the ADT guidelines and practice note on an interim basis in NCAT.

- 5. The Tribunal may excuse a person from complying with this Procedural Direction or any Practice Note or Guideline referred to in this Procedural Direction before or after the time for compliance.
- 6. Nothing in this Procedural Direction prevents the Tribunal from giving any directions concerning any aspect of practice or procedure in the Administrative and Equal Opportunity Division of NCAT that the Tribunal considers appropriate in any particular proceedings before the Tribunal.
- 7. This Procedural Direction is made by the President under s 26 of the *Civil and Administrative Tribunal Act 2013*.
