

# Paying Court Fines

**Within 28 days of a court ordering you to pay a fine, you will need to pay it in full, arrange to pay by instalments or request an extension of the time allowed to pay. If you do not make arrangements within 28 days, an additional \$65 penalty will apply.**

## How can I pay the fine?

You can pay by:

- **Online payment:** - online registry website (<https://onlineregistry.lawlink.nsw.gov.au>)
- **Credit card** –at the local court or by telephone.
- **Cheque or money order** –payable to the Local Court.
- **EFTPOS** –at the local court.
- **Centrepay instalments** – if you receive a Centrelink benefit, you can request deductions from your benefit. Complete the *Early Enforcement Payment by Centrepay Instalments* form, available from a local court or [www.localcourt.justice.nsw.gov.au](http://www.localcourt.justice.nsw.gov.au)
- **Instalments** – if you do not receive a Centrelink benefit, you can apply to pay by instalments direct to the court. Complete the *Application for Time to Pay Court Fines* form, available from a local court or [www.localcourt.justice.nsw.gov.au](http://www.localcourt.justice.nsw.gov.au)

You can also **ask for an extension** of the 28 days.

Contact the local court immediately if you cannot make a payment that you have agreed to make.

## What if I don't pay on time?

If you do not pay the fine or instalments on time, Revenue NSW will take further action on the fine and you will have to pay an extra \$65.

Revenue NSW can suspend or cancel your driver's licence or vehicle registration, send the sheriff to your house to take your property, take money from your bank account, order you to do community service, or for Commonwealth offences, take other action.

## What if I can't pay the fine?

If you cannot pay the fine, you might be eligible for a Work and Development Order (WDO) to be made by the Revenue NSW. A WDO allows you to clear your debt with activities like unpaid work, counselling, courses or treatment programs.

To be eligible for a WDO you must be homeless, have a mental illness, intellectual disability or cognitive impairment, serious addiction, or be experiencing acute financial hardship.

## Do I need to pay a levy or other costs?

Yes, if the court has made a cost order or a levy payable by law applies in your case. This can include:

- Victims Compensation Levy – payable on certain offences to contribute towards compensation for victims.
- Court costs – an amount for commencing the prosecution or action against you.
- Professional costs – legal costs payable to another party in the case.
- Witness expenses – costs for witnesses attending.
